A church is currently located in the adjacent multi-tenant building located to the west that is not greater than 150' from the 6276 Stage Road location. However, the 6276 Stage Road location has held an ON-Premises Beer Permit prior to the church occupying the location to the west. A representative with the new ownership of 6276 Stage Road called and had some questions about renewing the permit under a new ownership. It is my understanding that the board would take into consideration that the beer permit was existing to the location prior to the adjacent church acquiring occupancy.

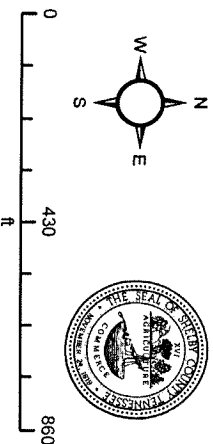
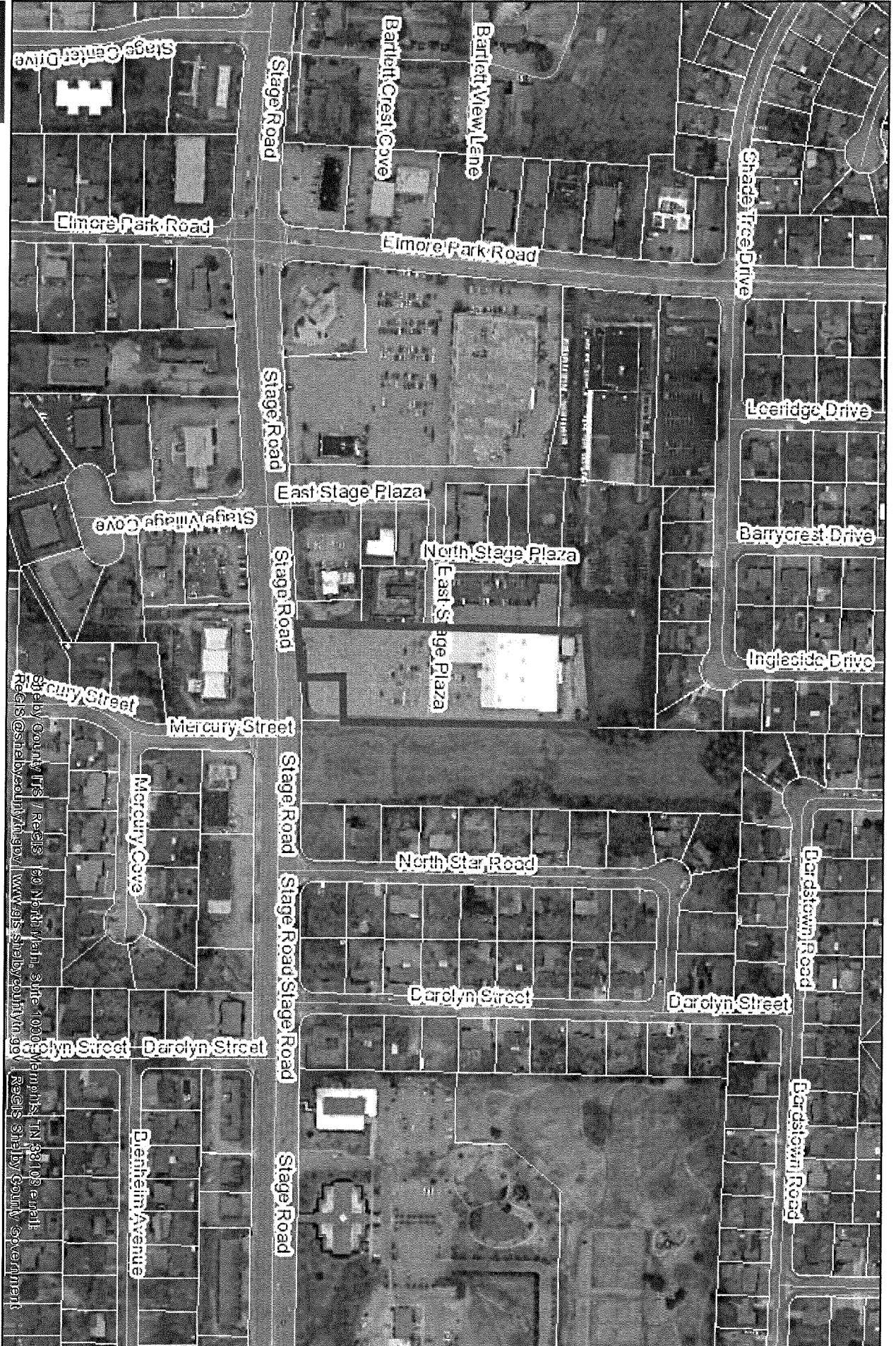
