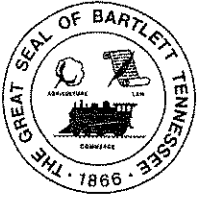

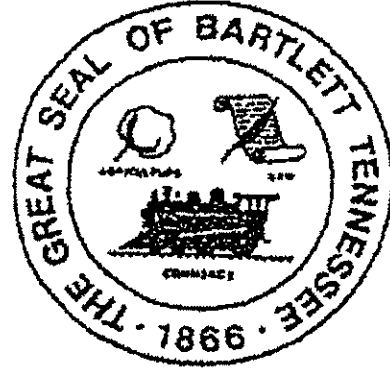

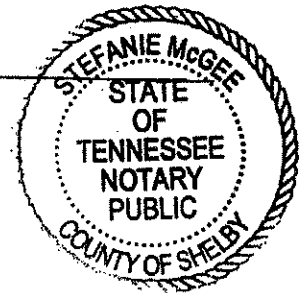

nial in their first round and another loss to Sevier County in the first consolation round. The Arlington Tigers entered the State competition ranked as the No. 3 Div. I-AAA dual team in the state according to pntn.com. The No. 3 ranking is the highest state ranking the team has achieved since the inception of the program.

The Tigers had a victory over Maryville in the first dual. However, in the second round Arlington was defeated by last year's State runner-up team, Science Hill, by one match.

tournaments.
