Mr. McKenney explained that if an applicant meets the criteria for beer sales set forth in state law and city ordinance, then a beer permit must be issued or the City would be ordered by a court to issue the permit.

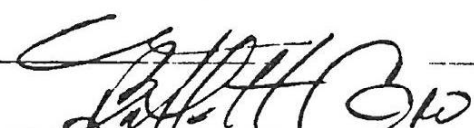

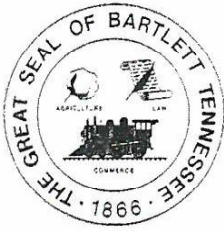
