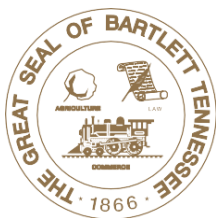

- (i) You will comply with all requirements of Title 9, Chapter 3 of the City of Bartlett Codified Ordinances.



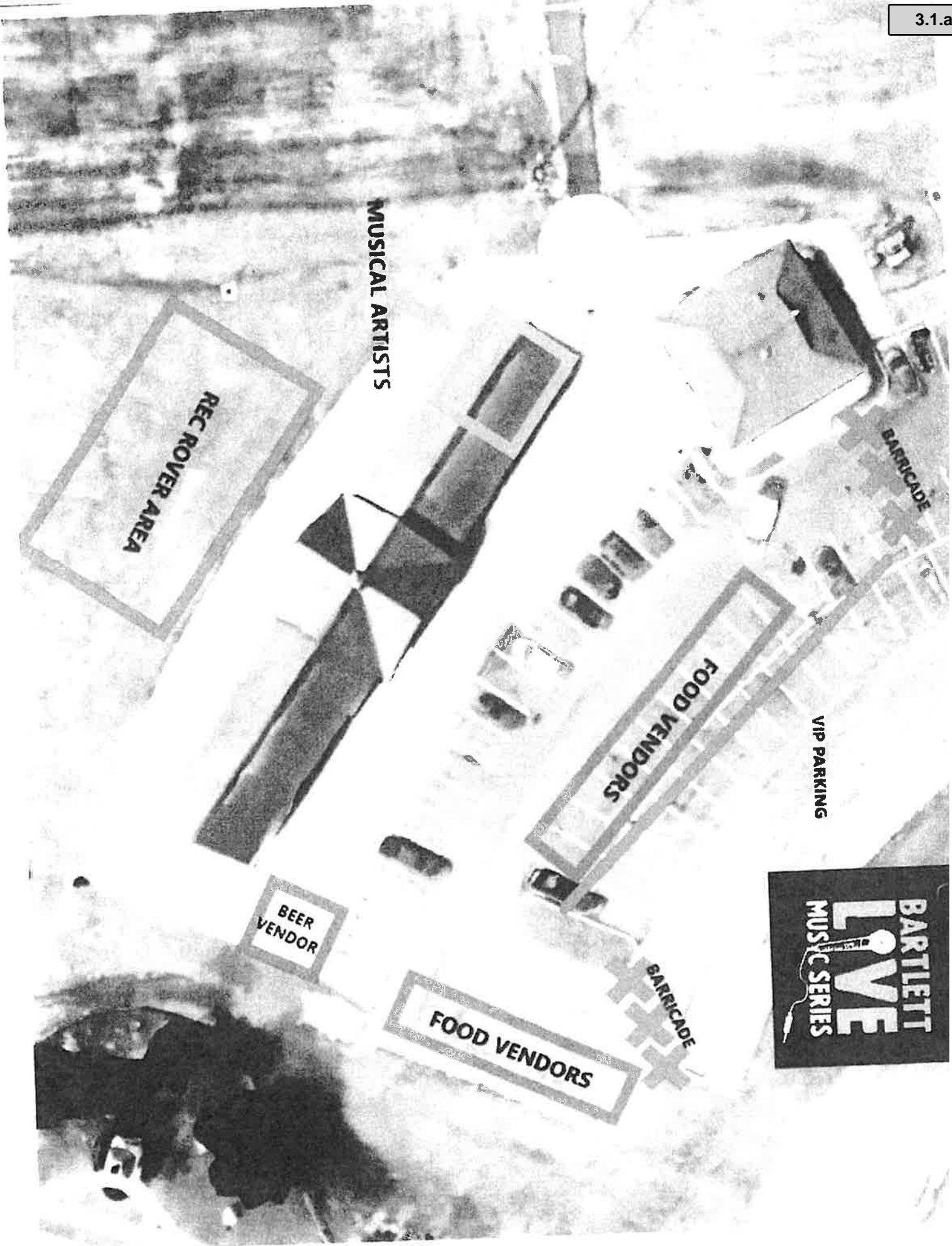

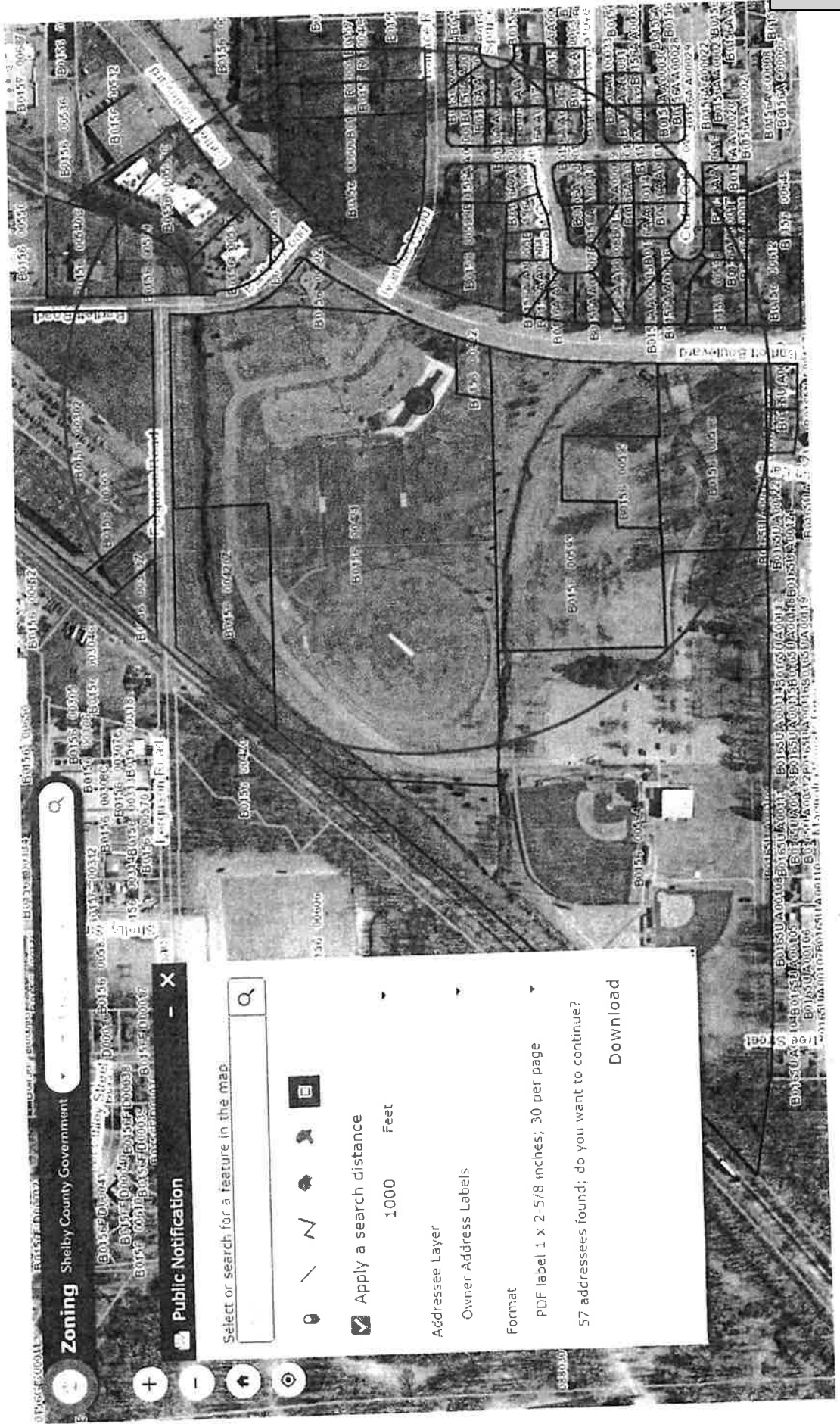
